

# **“FUTURITY CONTRACT”**

## **Go for the Gold Stallion Service Auction**

Oklahoma Palomino Exhibitors Association (O.P.E.A.)

I, being the owner/agent of the Stallion (Stallion's Name) \_\_\_\_\_ do hereby donate one (1) Stallion Breeding Service by the above named Stallion to the Oklahoma Palomino Exhibitors Association (O.P.E.A.) Go for the Gold Stallion Service Auction. I agree to breed the Mare owned or leased by the highest bonafide bidder. I further agree to be bound by the provisions contained herein, and all Rules associated with the O.P.E.A. Go for the Gold Stallion Service Auction and Futurity. I agree that once this Service is sold I will receive one (1) free entry in the Futurity. All of the foals regardless of color from said Stallion will be eligible to be shown in all Get of Gold Futurity Classes subject to Futurity Show Rules. **Mares and or Stallions must be AQHA, PHBA, APHA, PtHA or ApHC registered.** No foals resulting from Mares registered in other breed associations are eligible.

I understand that the proceeds of the Auction will be placed in a general fund to be disbursed in accordance with the Rules of the Go for the Gold Futurity. **There will be no refunds.**

Stallion owners will receive 10% of the total purse to be distributed based on the placings from the Stallion's offspring.

I acknowledge that all Veterinary bills, board, and other appropriate expenses associated with the service will be the sole responsibility of the Mare Owner. I agree O.P.E.A. will not be responsible or liable for any expenses or damages incurred by, or resulting from, the Mare or Stallion Owners participation in the Service. The Stallion and Mare Owners assume all risks associated herewith under the Auction, Service and Futurity. **O.P.E.A. offers no warranties, actual or implied, for itself or on the part of the Mare or Stallion Owners;** however, the Stallion Owner is expected to honor a "live foal guarantee" as is customary in the Breeding industry. I understand that if the Service is not sold by the cut off date, I will retain the right to purchase said Service at the minimum bid.

As the Stallion Owner I may elect to purchase my/our own Stallion Service (after the Stallion Service Auction closing date). Transfer of a free entry from a Stallion Owner/Mare Owner to another person will be \$75.00.
