COVID-19 HEALTH ACKNOWLEDGEMENT & LIABILITY WAIVER

I, _____, and my parent/guardian (if applicable) are aware of the potential spread of COVID-19 that could result in severe illness and potential death. My presence at the 2020 OPEA Go For The Gold Labor Day Show held on September 5, 6 & 7, 2020 at Claremore Expo in Claremore, Oklahoma ("Event") proves I voluntarily accept this risk by attending the Event and accept sole responsibility for any injury to myself and on behalf of my family, spouse, heirs, executors, administrators, assigns, and personal representatives, including, but not limited to, illness, damage, loss, claim, liability, or expense of any kind, that may be experienced or incurred in connection with my attendance at the Event.

I understand that the risk of being exposed to or infected by COVID-19 at the Event may result from the actions, omissions, or negligence of myself, and others, including, but not limited to, OPEA or GFTG, and/or its employees, officers, directors, representatives, agents, show staff, volunteers, Event participants/attendees and their families. I hereby release, covenant not to sue, discharge and hold harmless OPEA or GFTG, and/or its directors, officers, employees, representatives and agents from any claim associated with allegedly being exposed to or infected by COVID-19 as a result of participating in Event activities and/or being on Event show grounds.

HEALTH PROTOCOLS:

- Exhibitors and attendees should not congregate in groups of larger than 10 people and must follow social distancing guidelines.
- Put 6 feet between yourself and people who are not from your same household or household contact.
- Those seated in the stands will be asked to leave two (2) vacant seats between each person from a separate household or household contract.
- Exhibitors and attendees are required to wear face protection/face coverings in common areas, including but not limited to the stands, show office and bathrooms.

HEALTH REPORTING:

- I have not reported new or worsening symptoms of possible COVID-19 in the last 14 days, including cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, feeling feverish or a temperature greater than 100°.
- I have not had close contact with a person symptomatic or confirmed to have COVID-19 in the last 14 days.
- I have not been diagnosed with COVID-19 within the last 14 days. If I have been infected by COVID-19 at any time, I have been medically released to return to normal activities.
- If I develop a fever and symptoms, such as a cough or difficulty breathing while at the Event, or if I am diagnosed with COVID-19 while at the Event, I will self-quarantine and immediately report this information to OPEA or GFTG management.
